Comes the Dissolution Committee ("BTGCA Dissolution Committee") of Defendant, Burley Tobacco Growers Cooperative Association ("Co-Op") by Members, Penny Greathouse, Mitch Haynes and Scott Haynes, through their counsel, and by Members, Al Pedigo, Donald Mitchell and Eddie Warren, through their counsel, and provide this Interim Report To Court:

- 1. All Tobacco stocks, Hemp and other physical assets of the Co-Op have been liquidated.
- 2. All staff and employees have been terminated with severance and releases, and office facilities and all equipment leases have been ended.
- 3. First round gross distributions¹ of \$15,977,334.00 less percentage fee to Plaintiffs' counsel, net to \$14,742,000.00, to the 2,600 Settlement Class Members has occurred.
 - Fully insured cash on hand is +/-\$13,211,466.44 as of October 1, 2022: 4.

¹ Four distributions with the last of occurring on September 1, 2022.

- a) Cash in account with Wells Fargo Bank: \$577,585.03²
- b) Cash in Partial Distribution account with Traditional Bank: \$12,633,881.41³
- c) Total Available Cash in both accounts will be +/-\$12,445,994.91.
- 5. Necessary expenses incurred and paid over the course of the winding up of business of the Co-Op under the Dissolution Committee (September 2021 through August 31, 2022) are shown on the *complete* check register of the Co-Op with Wells Fargo Bank and *complete* check detail which are attached hereto. The attached complete check register and complete check detail also include some partial settlement distribution payments checks, some Court approved extraordinary counsel fees, and some checks payable for some percentage class counsel fees (which though are not necessary Co-Op dissolution expenses incurred under the auspices of the Dissolution Committee, however for the purposes of providing and unredacted check register, are not omitted or otherwise "blacked out").
- 6. Minutes of the meetings of the Dissolution Committee through this date are attached hereto.
- 7. Remaining matters to wind up Co-Op financial affairs without limitation include replacement of Danny McKinney retirement liability through purchase of annuity for him, which is underway; and filing FYE 9/30/22 Income and Payroll tax returns and 9/30/23 Income tax returns; completing surrender of 4th Life insurance policy; cashing in Brighthouse annuity at maturity on November 23, 2023 and Class Counsel's mail notice with opt-out cards to Class Members re funding Burley and Dark Tobacco Producers nonprofit out of said annuity proceeds (income plus amount not claimed by Class Members).
- 8. Articles of Dissolution have been approved by the Dissolution Committee and counsel and will be filed the week of October 10, 2022.
- 9. Second round gross distribution of no less than approximately \$11,000.000.00 less percentage fee to Plaintiffs' counsel, net to no less than approximately \$10,175,000.00, to the 2,601 Settlement Class Members is planned for October, 2022.
