6. Facts and Issues: (Brief statement of facts, claims, defenses and issues litigated).

On June 10, 2020, a class action settlement was reached between the

appellee parties. As part of that settlement, the appellees agreed among themselves

that \$1.5 million dollars of the co-op's held funds would be transferred to a new non-

profit entity (comprised largely of the same individuals who ran the co-op).

Roger Quarles and the above Appellants hired W.H. Graddy & Associates to object. The objection, in general terms, was that the \$1.5 million transfer was an illegal gift of coop assets belonging to the coop members, unfair to coop members no longer raising tobacco, a waste of coop assets, and unreasonable and unacceptable. Quarles and the other objectors hired the firm on a contingent basis, meaning it would only be compensated out of any value created for the class.

Hank Graddy appeared at fairness hearings on February 24, March 1, and March 8, arguing that the \$1.5 million should be used to benefit the class members directly and monetarily, as opposed to being given to the non-profit. After the hearings, class counsel filed pleadings that continued to support this \$1.5 million gift to the non-profit. Graddy argued that the gift was illegal. But, alternatively, Graddy argued that coop/classs members, should be allowed to vote on whether to approve the gift. The trial court found that the \$1.5 million gift was a legal "predissolution" gift, but also ordered that one of two things should happen with the money:

First, if the non-profit could become self-sustaining within 2 years, the \$1.5 million would be returned to class members. But if the non-profit could not become self-sustaining, the class members could each vote whether to give that sum to the new non-profit or be distributed to the class members, to be decided by majority vote. Upon a motion to reconsider, the trial court ordered that the non-profit would get \$175,000 of that sum, reducing the amount available to class members to \$1,325,000. Each class member would be given a vote to either receive his/her pro rata share of that \$1,325,000 or gift their share to the non-profit. That vote took place when the postcard ballots were mailed to the 2,605 class members on April 1, 2023.

Since the voting began, approximately 1,880 of class members responded that they wanted their pro rata share of the \$1,325,000 to be distributed to them, not the non-profit.¹ Approximately 38 of the class members have responded that they wanted their pro rata shares to go to the new non-profit.

On August 6, 2021, Graddy moved the court to hold a fairness hearing and award attorney's fees and expenses to W. H. Graddy & Associates not to exceed 24% of the \$1.325 million the firm's efforts made available to the class, based upon the limit on percentage of award of attorney's fees as set forth in all prior public notices concerning attorney's fees in this class action. On date, the trial court denied the motion, ruling that Graddy had not created any new value.

On March 17, 2023, Graddy filed a renewed motion for an award of attorneys' fees, with such fees not to exceed 7.5% of the \$1.325,000, not to exceed \$99,375.00. That matched the percentage fee award approved for the McBrayer firm. This renewed motion was denied. Graddy filed a motion pursuant to CR 59 to alter, amend or vacate such order. This CR 59 motion was denied. This appeal followed.

¹ Graddy also argued that the notice sent to class members regarding the vote was insufficient, as the envelope did not have any return address. This gave the envelopes the appearance of standard spam mail. Prior notices in this case had return addresses. Ultimately, the "return rate' on the vote was lower than the claim rate, and the change in appearance likely caused this. On June 30, 2023, Graddy asked for a motion hour to be heard on resending the notice. The trial court denied the request and ordered him to argue the motion on the spot, ultimately denying it. This may become the subject of another appeal.



<u>ORDER</u>

The above-styled matter came before the Court on August 20, 2021, on a Motion for Entry of Order of Method and Manner of Actual Notice of Petition for Allowance of Attorneys' Fees and Notice and a Motion for Award of Attorneys' Fees and Notice, both filed by W.H. Graddy & Associates, W. Henry (Hank) Graddy, IV and Dorothy Rush, counsel for the Roger Quarles, et al., Objectors. Having reviewed the Record, relevant case law, and memorandums of parties, as well as having heard the arguments of counsel, this Court **HEREBY DENIES** the motions for the following reasons:

A common fund recovery is only applicable to attorneys who create a common fund. *See Kincaid v. Johnson, True & Guarnieri,* LLP, 538 S.W.3d 901, 919-20 (Ky. App. 2017). In this case, there has been no change in the common fund available to the class members, though the distribution of certain assets has changed. The mediated Partial Settlement as approved by the Court in its Amended Opinion and Order of July 26, 2021 treated the gross sum of \$1.5 million as a pre-dissolution grant by the Board of

Directors of BTGCA to the newly-formed Burley and Dark Tobacco Producers Association, under certain modified terms, that was not to be reduced by any claim for attorneys' fees except to compensate the actual time spent by Class Counsel overseeing the postcard opt-out program.

At the core, what the Court did in response to the many objectors was to change the method and manner of distribution of the \$1.5 million, without any guarantee it would be given to the class members. While the class members may, upon the conclusion of two years, withdraw their contribution, this is entirely dependent on the individual and is consistent with a member's right to withdraw their contribution. Therefore, the amount potentially granted to the class is speculative, as it is possible that all or most class members will choose to donate their share to the Burley and Dark Tobacco Producers Association and remain members of said organization. This means that Graddy as counsel for certain objectors did not create a common fund or increase the assets of the common fund; rather, Graddy helped provide a different framework for the distribution of the \$1.5 million.

Graddy was not involved in the prosecution of this action; he was neither class counsel nor did he take part in the original settlement in this case. He became involved in this case after the Court asked for objections from the class, and though he was involved in many hearings and proceedings following his clients' objections, he was ultimately involved in the narrow issue objected to by his clients. Therefore, while he

was certainly an effective attorney for the sake of his clients, his role in this case was largely tied to the desires of his clients—even if those desires were beneficial to the class.

While Graddy advocated for its clients' position on the settlement, it has not shown that this advocacy alone was the cause of the change in how the \$1.5 million will be distributed. The Court took into consideration the concerns raised by the unrepresented objectors regardless of their pro se status. Aside from the Objectors represented by Graddy, there were at least ten (10) other objections filed in opposition to the 1.5 million distribution. Graddy has not established that its actions "created" something more than did the pro se objectors or that, absent its presence in the case, the Court would not have sustained the objections. The Court has been extremely cognizant throughout this process of its position as the fiduciary for the class. As such, the Court paid great care to ensuring that the class members were heard and properly protected, as demonstrated by the Court's decision to deviate from other terms of the settlement, such as the other firms' awards of attorneys' fees and the proposed class definition.
