The Defendant, Burley Tobacco Growers Cooperative Association ("BTGCA") having moved for approval to transfer its remaining net assets held at Traditional Bank to the Settlement Agent (Angeion) for deposit in its Qualified Settlement Fund Trust Account before September 30, 2023, there being no objection and the Court being sufficiently advised, IT IS HEREBY ORDERED AND ADJUDGED that BTGCA and its appointed Liquidating Officers, Al Pedigo or Penny Greathouse, are authorized to cause the wire transfer of the remaining balance of \$1,438,273.78 from Traditional Bank to Angeion's Qualified Settlement Fund Trust Account, which shall be held by Angeion subject to further orders of the Court.

No just cause for delay being shown, this is a final and appealable Order.
