- 1. The Status Report is accepted and:

 - b. Class Counsel's remaining reporting obligations under the 8/4/23 Fund Order are only those per ¶5a and ¶9(ii), relating to the escrowed \$30,000.00.
- 2. Payment is approved to the McBrayer firm of the \$11,250.00 allowed in \$5b of the \$/4/23 Fund Order.
- 3. Residual amounts from the Fund may remain in the qualified settlement fund established by the Settlement Administrator for this case and may ultimately be combined with residual amounts from the net dissolution proceeds for the *cy pres* payments directed in ¶9 of the 8/4/23 Fund Order.
