
DEFENDANTS

The Court having reviewed the Status Report on Co-op Reserve for the Burley Tobacco Growers Cooperative Association in dissolution (“BTGCA”) being held in the Sturgill Turner law firm’s IOLTA client trust account, listing all receipts and disbursements, and being sufficiently advised, said Status Report is accepted. Sturgill Turner shall not be required to make any further formal Status Report concerning the Co-op Reserve, but shall continue to provide all additional information about any further receipts or disbursements to Class Counsel and to Chambers. The remaining funds in the Co-op Reserve now, and if any other funds are received, are expected to remain below \$10,000, therefore, the Co-op Reserve is ADJUDGED to be Residual Funds from the Class Settlement within the meaning of CR 26.05(6)(a). IT IS ALSO ORDERED that when and if Sturgill Turner writes any *cy pres* payment checks to the three specified Kentucky state university colleges of agriculture and the Kentucky IOLTA Fund pursuant to the Court’s January 24, 2024 Order, copies of such checks shall be provided to Class Counsel and to the Court’s Chambers, and a notice of such *cy pres* payments shall be filed in the record. Alternatively, Sturgill Turner may transfer the balance of the Co-op Reserve to be combined with other Residual funds from this case held in trust by the Settlement Administrator, the McBrayer firm, or other Court designee.
