Settlement Class Counsel having filed a Motion re Discharging Settlement Administrator and re Dissolution QSF Remainder, the Motion having come on for hearing as noticed on January 24, 2025, there having been an opportunity to be heard, and the Court being duly and sufficiently advised, IT IS HEREBY FOUND and ORDERED as follows:

1. With respect to the Settlement Administrator, Angeion Group LLC (“Angeion”):
 - a. Angeion’s accounting for funds it received into and disbursed from its qualified settlement fund for this case (“the QSF”) is ACCEPTED;
 - b. The \$155,887.16 total invoiced by and paid to Angeion for its work as Settlement Administrator is accepted and it is HELD that no further payment to Angeion or refund from Angeion is due with respect to this case;
 - c. It is FOUND that Angeion has fully complied with the Order for Ending Settlement Administration by Angeion Group LLC, entered October 2, 2024, including turning over to McBrayer PLLC the \$44,924.13 remaining in the QSF; and
 - d. Angeion is DISCHARGED from its duties and obligations to this Court, the parties, and the Settlement Class in this case.
2. It is HELD that there are to be no further Class-wide distributions in this case.

3. The residual amount from the dissolution portion of the QSF (“the Dissolution QSF residual”) is FOUND to be \$37,749.31, and no part of that amount is to be used to reissue uncashed checks from previous dissolution distributions or (at this time) reserved for funding functions or facilities previously supplied by Angeion as the Settlement Administrator.

4. The Dissolution QSF residual is to remain held in escrow by McBrayer PLLC pending further orders of the Court.
